**Subject:- REVISION OF BICYCLE, MOTOR CYCLE AND MOTOR CAR ADVANCES.**

The undersigned is directed to refer to Finance Division's O.M. No. F.8 (2)-Reg.7/87(Vol.II)-328 dated 12.12.2011 on the above subject and to state that on the representation of low paid Government employees, the matter has been reviewed. It has been decided to revise the eligibility criteria for grant of Bicycle Advance, Motor Cycle Advance and Motor Car Advance, w.e.f. 01.07.2012 as under: -

S#	Type of Advance	Eligibility	Amount
i)	Bicycle Advance	On pay upto Rs.7500/- p.m.	Rs.7000/-
ii)	Motor Cycle/Scooter Advance	On pay between Rs.7501/- to Rs.19,999/- p.m.	Rs.75,000/-
iii)	Motor Car Advance	On pay of Rs.20,000/- p.m. and above	Rs.450,000/-

2 It has also been decided that the names of officials who are already on the waiting lists for the above referred advances may not be deleted from the said lists. The other conditions on the subject will continue to be in force as before.
